#### **Did You Know?**

- 1 in 4 children in Ohio lives with food insecurity.
- In Wayne County, 21% of people live below 150% of poverty level.
- According to The Self-Sufficiency Standard for Ohio 2013, "For two adult families, the emergency savings goal needs to cover half of the family's total living expenses for four months, assuming that only one adult loses his/her job at a given time."
- According to the same study, a family of four needs two adults working full-time, each earning \$15 per hour, to cover necessities without using any government or private assistance.
- According to the same study, there
  is no place in Ohio where a single
  person earning the state's \$7.85
  per hour minimum wage can meet
  his or her own basic needs.



space for the service. We also utilize many dedicated volunteers who make the whole thing work.

Our VITA site prepared **153** tax returns in 2014, for a total of **\$302,928** in refunds and tax credits claimed! Our goal is to serve even more families in 2015.

This is an excellent benefit to our community, and you can be a part of it. If you decide to volunteer as a tax preparer, you will receive training materials in December and will need to take a test online at the IRS to be certified. You can also volunteer to be a greeter. The Pickett's provide lots of support and assistance, and our volunteers have fun!
